

Disincentive the uptake of PD and Home HD will have a negative impact on the key strategy for relieving pressure on already overcrowded facility haemodialysis units, which are constantly experiencing unprecedented capacity pressures across Australia.

In June 2023, the Australian and New Zealand Society of Nephrology (ANZSN), the Renal Society of Australasia (RSA), The Australian and New Zealand Paediatric Nephrology Association (ANZPNA) and Kidney Health Australia (KHA) wrote to the Independent Hospital Pricing Authority (IHACPA) regarding their serious concerns on the reduction, by IHACPA, of the activity-based funding allocation.

The changes were believed representing a major drop (54%) in PD funding in 2023/24 that will create a significant financial disincentive for commencing patients on PD, despite the benefits to patients and cost savings for the healthcare system.

The proposed change of PD to a Tier 2 Non-Admitted activity requires adjustment and does not accurately reflect costs. Placing a severe financial disincentive on commencing patients on PD will greatly exacerbate these pressures thereby increasing the risks of serious clinical incidents and death. Concern has also been raised on any changes to Tier 2 Non-Admitted Services Classification that may adversely impact and undermine the benefit of Home HD.

"IHACPA pricing is conducted as a technical exercise within specific terms of reference and not subject to opinion-based change". If there has been a reduction in pricing, this usually arises from reduced costings provided by hospitals across Australia. Correct identification of a hospital's costs is therefore critical and a major cost change in a different State (or a local health region within the state/territory) might influence the national price.

It is therefore critical for the renal service managers and clinicians to engage with the periodic costing exercises for their services. It is this data which is provided to IHACPA for their determination, and this data which has resulted in the reduction in price.

香港中文大學 An International Survey on Nursing Practic of Fatigue Management in Kidney Care. **An International Survey on Nursing Practice**

Fatigue is a common symptom in patients with kidney failure, and there is always room for improvement in terms of assessment and management of fatigue in routine kidney care.

Understanding how nephrology nurses assess and manage this distressing symptom may shed light on the development of clinical guidelines for improving fatigue management. The study aims to evaluate nursing practice on management of fatigue in patients with kidney failure across countries and clinical settings.

Participants are invited to give their informed consent through an online survey, after which they will be instructed to complete the online survey to collect background information and evaluate their clinical practice. It will take about ten minutes to complete the online survey.

Confidentiality will be protected by an anonymising data. No personal identifier will be used in the research records. All research records will be store in an encrypted computer.

Participation is on a voluntary basis, and you are free to withdraw from the study at any time.

MEMBER PROFILE



Name: Jo Beer

Role: Senior Renal Dietitian



What is your current role and where are you from? I work at Sir Charles Gairdner Hospital in Perth WA as their senior (and only) renal dietitian.

How long have you been with The HOME Network? I have been with The HOME Network for a couple of years now. I was

encouraged to join THN by a previous WA member to add some more dietetic input to the team.

What prompted you to join The HOME Network? I am very keen to optimise quality of life and enjoyment of food with people needing maintenance dialysis and also learning not only from health professionals within the Network but also from those with lived experiences. That way I can improve the way I deliver advice and education and also help to improve the overall service we offer.

What projects have you been involved with? Currently I am finalising my PhD - I have been doing it part time for nearly 4 years now. I have been investigating the use of telehealth in delivering essential nutritional advice to those receiving dialysis - in particular we are looking at managing serum phosphate. I developed a 12 week education program that is delivered via a Smartphone App. We have 23 sites across Australia taking part and have recruited nearly two thirds of our target sample number (166). Aiming to have it finished by the end of the year to start to analyse the data next year ready for publication.

Future plans with The HOME Network? Once my PhD is completed, I would like to collaborate with the team and consumers to see how we can further improve quality of life and optimise diet, especially with the new emerging evidence in the role of plant-based foods in CKD, and see how technology and AI can be used to assist this. ©
